Step 2 Prepare the following documents:

School/academic records from the past two years translated into English (copies must have a school stamp) with a grade scale

Letter of recommendation from the current teacher or principal translated into English

Copy of passport (picture page)

Custodianship documents (unless applying for homestay or parent lives in Calgary with child)

Optional: Provide documentation of international English testing/training completed (e.g., TOEFL, IELTS)

Step 5 Notification of Acceptance

You will be notified within two weeks of receipt of a full application package if the application has been accepted (please note a Skype interview may be requested before acceptance). An invoice will be issued for payment of full tuition, health insurance and other applicable fees. The Letter of Acceptance will be issued once all fees have been paid in full.

Step 6 Study Permit

Once the Letter of Acceptance has been received, the student must apply for a Canadian study permit at the nearest Canadian embassy/consulate.

Student & Parent Participation Agreement

The Calgary Board of Education (CBE) wants the experience of all students to be exciting and rewarding and there are expectations in place to ensure that each student's experience is successful, however, we want to remind students and parents that this is an educational high school program first and foremost.

Both student and parent must read the following guidelines carefully and sign indicating that they are understood and will abide by them.

The CBE reserves the right to expel a student and return him/her home, at the parent's expense and without refund of tuition and other fees, for violating the following guidelines.

 studies with the CBE.
- I understand that once I turn 18 years of age, I will be considered an independent student* according to Alberta's Education Act, section 1(1) (n). This means that the CBE is not permitted to share any information collected about me during the time I attend a CBE school, with anyone, including my parents or homestay family (Education Act, sections 6(1), 56(3)(b), 257(2)). Refund Policy

Please ensure you have read and understand our refund policy. If:

- Your Study Permit is Denied: You will receive a full refund if your Study Permit application is denied by Immigration, Refugees and Citizenship Canada. A copy of the rejection letter must be submitted with the Tuition Refund Request Form.
- You Cannot Attend for Other Reasons: You will receive two-thirds (2/3) refund of the tuition if you withdraw prior to the commencement of the program as per the Duration of Program (study) dates on the letter of acceptance.
- Parent's Immigration Status Changes (and meets eligible criteria):
 - o Proof must be presented to the CBE Welcome, 1221 8 Street SW, Calgary, AB, Phone: 1.403.817.7789
 - Full tuition refund for September to June program if proof submitted before September 30 of the school year. No refunds after September 30.
- You Withdraw or are Withdrawn from the Calgary Board of Education: Once your program has begun as per the Duration of Program (study) dates on the letter of acceptance, no refund will be given. Semester two refunds will not be granted on full year enrolments.
- Late Arrivals: When a student arrives late, there will be no refund for the time period missed.

Subject to a \$250 refund processing fee; health insurance is non-refundable after program start date.

Families will be required to pay full year fees at the time of registration.

Please note: The original application fee is not refundable. Also, tuition can only be refunded by the same method of payment and to the same person who originally paid.
