



## REGISTRATION OPENS ON MARCH 3, 2025

The Calgary Board of Education would like to take this opportunity to thank you for studying with us and we trust that your school year has been enjoyable.

According to our records, your program with the Calgary Board of Education will soon be over. If you are planning to continue your studies, you need to submit fees for the next school year.

### REQUIRED FEES FOR 2025-26

Fee	Full Year (September to June) All grades	One Semester* (High School only)
Tuition	\$13,000.00	\$6,500.00
Health Insurance (mandatory)	\$550.00	\$275.00
<b>Total</b>	<b>\$13,550.00</b>	<b>\$6,775.00</b>

\*The semester fee is applicable only for those high school students who will either be graduating or returning home after one semester. Full year students cannot pay by the semester.

For elementary and junior high students (grades K-9) who will study for periods of less than one full school year (a full school year means from September to June), please contact Global Learning for eligibility and fees.

### STUDENT CONTACT UPDATES

## STUDY PERMIT RENEWAL

According to Immigration, Refugees and Citizenship Canada (IRCC):

*Only some people can charge a fee or receive any other type of payment to represent or advise you on a Canadian immigration proceeding or application. These are:*

- *lawyers and paralegals who are members in good standing of a Canadian provincial or territorial law society,*
- *immigration consultants who are members in good standing of the Immigration Consultants of Canada Regulatory Council.*

*These people are called “authorized” representatives. IRCC will not deal with representatives who charge for their services **and** are not members of one of the above groups.*

As we do receive fees from you, we cannot assist you with renewing your study permit and this applies to the staff at Canada Homestay Network as well.

If you have strong English skills and follow the instructions very carefully, you may be able to apply directly using the online application process (<https://www.canada.ca/en/immigration-refugees-citizenship/services/study-canada/extend-study-permit.html>).

However, you may want to hire a **Certified Immigration Consultant** to assist you. There is a fee for this service which may be worth paying for the peace of mind in ensuring your application is done accurately and help you avoid delays or even a rejection of your application.
